
TERMS AND CONDITIONS


6. Attested copies of ITC / PTC with up to date validity should be enclosed with the quotation, failing which the quotation will be liable to be rejected.
7. The quotationer shall have to deposit Rs.5,000.00 (Rupees five thousand) only as security money in the shape of deposit at call from any nationalized Bank guaranteed by Reserve Bank of India in favour of the District Magistrate & Collector, South Tripura, Udaipur.
8. The undersigned reserved the right to reject or accept any quotation partly or wholly even the lowest bid without assigning any reason.
9. Security money deposited in the shape of D/Call will be forfeited if the supplier fails to supply within the period specified in the supply order.
