
Terms & Conditions

2. Tender should be accompanied by bank D. Call for Rs, 2000(Two thousand) only for the vehicle drawn on the State Bank of India/ United Bank of India / Gramin Bank of India/ Tripura State Co-operative Bank etc. Agartala/Udaipur/Amarpur/Belonia/Sabroom/Santirbazar in favour of the District Magistrate & Collector, South Tripura as earnest money which is refundable within one month after opening of the tenders.
3. The interested parties willing to purchase the vehicle mentioned above are requested to quote the rate both in words and figures in a sealed cover mentioning value of the condemned vehicle.
4. Quoted auction money should be deposited in full within 7 days from the date of acceptance of the tender by the successful bidders failing which the earnest money deposited by them shall be forfeited.
5. Tax like VAT etc. is applicable as per rules /act.
